## **Product description**

A-15 Steel Deck - FireMaster Marine Plus Blanket 15 mm x 64 kg/m<sup>3</sup>,

composed of a structural steel deck insulated on the exposed side (underside deck) with a single layer of 15 mm thick FireMaster Marine Plus Blanket (manufactured by Thermal Ceramics with density 64 kg/m³) applied across the tops of stiffeners following their contours.

The nominal blanket width is 610 mm and is to be compressed to a width of 600 mm to ensure compression at joints.

The blankets are held in place using copper coated steel pins (Ø 3 mm / typically 60 mm long) welded to the bulkhead and 38 mm friction-fit washers. The pins are to be installed with a nominal spacing of 200 mm across the blankets and maximum 350 mm along the blankets, whereas pins at the joints between blankets shall have a nominal spacing of 100 mm from the blanket edge.

The installation is to be performed according to the manufacturers Fire Protection Systems Information, reference No. FM MS 01 PW and No. FM 4.97.
