## **Product description**

A-60 Aluminium Bulkhead – 2 x 50 mm FireMaster Marine Plus Blanket,

composed of a structural aluminium bulkhead insulated on each side with a single layer of 50 mm thick FireMaster Marine Plus Blanket (manufactured by Thermal Ceramics with density 70 kg/m³), applied across the tops of stiffeners following their contours on stiffened side.

The nominal blanket width is 610 mm and is to be compressed to a width of 580 mm to ensure compression at joints.

The blankets are held in place using stainless steel pins with bi-metallic anchor (Ø 3 mm / typically 65 mm long) welded to the bulkhead and 38 mm friction-fit stainless steel washers. The pins are to be installed with a nominal spacing of 240 mm, whereas pins at the joints between blankets shall have a nominal spacing of 100 mm from the blanket edge.

The installation is to be performed according to the manufacturers Fire Protection Systems Information, reference No. FM MS 02 PW and No. FM 4.64.
